

CASH STASH

Terms & Conditions

GENERAL

1. The Cash Stash promotion will commence Wednesday 10 June 2026 and run every Wednesday evening until Wednesday 26 August 2026.
2. This promotion is open to all financial members of The Bears Group are eligible for the promotion.
3. Members can earn entries into the weekly draws from Thursday 10:00am each week until 9:29pm the following Wednesday.
4. Members will earn one (1) entry with every \$10 play (turnover) on the gaming machines with their membership card inserted at Burleigh Leagues Club.
5. Members will earn double ticket entries between 5:00pm – 8:00pm every Wednesday promotional day.
6. Members can enter as many times as they like during the promotional period when they meet entry criteria.
7. Entries will be deleted following the conclusion of each Wednesday promotional draw day and will not be retained for future promotional draws.
8. Members must be present on the draw days and times to win.
9. Members selected from the electronic draw system have two (2) minutes to claim their prize from the specified draw area. If the selected winner does not present themselves within two (2) minutes of being announced, they forfeit their claim to the prize and a redraw will occur until a winner is found.
10. It is the responsibility of eligible members to position themselves within Burleigh Leagues Club where they can hear the public-address announcements.
11. Winners must present their membership card to the promotion host when claiming their prize. Additional proof of identity may be requested at the discretion of management.
12. Draws will be conducted every Wednesday evening at approximately:
 - a. 8:00pm
 - b. 8:30pm
 - c. 9:00pm
 - d. 9:30pm
13. A total of four (4) winners will be drawn each promotional draw day.
14. Each selected winner will play the Cash Stash gameboard for a chance to win up to \$1,000 cash.
15. The Cash Stash gameboard consists of five (5) levels with six (6) cards per level.
16. Winners must select one (1) card from each level of the gameboard.
17. If a winner selects a card displaying a cash value, they may choose to:
 - a. Take the displayed cash prize and end their game; or
 - b. Continue to the next level for the chance to win a higher cash amount.
18. If a winner selects a non-cash "X" card during gameplay, they will return to Level 1 and receive the base prize of \$100.
19. Gameplay continues until:
 - a. The winner elects to take a cash prize;
 - b. The winner reveals an "X" card and receives the base prize of \$100; or
 - c. The winner reaches the maximum prize of \$1,000.
20. Members may only win once per Wednesday promotional draw day.
21. Following each draw, all game cards will be returned to the gameboard and shuffled ahead of the next draw.
22. The Cash Stash gameboard contains the following prize structure:
 - a. LEVEL 1
 - i. Six (6) x \$100 cards
 - b. LEVEL 2
 - i. Two (2) x \$0 cards
 - ii. Four (4) x \$200 cards
 - c. LEVEL 3
 - i. Three (3) x \$0 cards
 - ii. Three (3) x \$250 cards
 - d. LEVEL 4
 - i. Four (4) x \$0 cards
 - ii. Two (2) x \$500 cards
 - e. LEVEL 5
 - i. Five (5) x \$0 cards
 - ii. One (1) x \$1,000 card
23. The promotional prize structure is as follows:
 - a. Minimum Prize PP: \$100
 - b. Maximum Prize PP: \$1,000
 - c. Average Prize PP: Approximately \$140
24. The average weekly promotional prize pool is approximately \$553.

STANDARD CONDITIONS
