

SUPER SATURDAY

Terms & Conditions

General

1. The Super Saturday promotion will commence on Saturday 13 June 2026 and run every Saturday until Saturday 29 August 2026, unless extended, amended or cancelled at the discretion of Burleigh Leagues Club.
2. The promotion is open to all financial members of The Bears Group.
3. Members will earn one (1) entry for every \$10 turnover on gaming machines between 10:00am and 8:59pm each Saturday whilst using their valid Burleigh Leagues Club membership card.
4. Members will receive double entries into the promotion every Saturday between 3:00pm and 6:00pm.
5. Members may earn an unlimited number of entries during each promotional period, provided the entry criteria are met.
6. Entries are valid for the Saturday on which they are earned only. All entries will be automatically purged immediately following the final 9:00pm draw each Saturday and will not carry forward to future draw periods.
7. Members must be present within Burleigh Leagues Club at the time of the draw and actively playing a gaming machine with their membership card inserted to be eligible to win.
8. Draws will be conducted electronically from a virtual barrel every Saturday between 6:00pm and 9:00pm.
9. Members selected from the electronic draw system will have two (2) minutes to present themselves to the promotional host and claim their prize. If the selected member does not present within the allocated time, the prize will be forfeited and a redraw will occur until a winner is determined.
10. It is the responsibility of eligible members to ensure they are positioned within the Club where they can hear promotional announcements.
11. Winners must present their membership card when claiming a prize. Management may request additional proof of identity at its discretion.
12. Seven (7) winners will be drawn each Saturday as follows:
